

FEBRUARY HOUSING STARTS

- Housing starts increased 9.0% in February to 1.525 million units at an annual rate. The consensus had expected a smaller gain of 3.0%. Starts were revised down slightly for both December and January.
- Nationwide, single-family starts rose 10.3% and multipleunit starts increased 4.1%. By region, the jump in starts was due to the South and the West. Starts fell in the Northeast and also in the Midwest, where they were the third lowest for any month since 1983.
- New building permits fell 2.5% in February to 1.532 million units at an annual rate, a slightly larger drop than the consensus expected. Most of the drop in building permits was attributable to single-family units. Building permits were down 28.6% versus February 2006.

Implications: Despite the headline bounce in housing starts the pain continues in home building. The 3-month moving average of starts fell for the 12th straight month and the year-to-year drops in starts (28.5%) and permits (28.6%) are near the worst since 1991. Moreover, in March the National Association of Home Builders Market Index reversed most of February's gain, dropping from 39 to 36. However, a glimmer of light can still be made out at the end of the (long) tunnel. Unlike the 3-month moving average of starts, the 3-month moving average of permits seems to have turned a corner a couple of months ago. That average dropped for eleven straight months in 2006 but has risen for the past two months.
