» Index Description

- » The ISE Clean Edge Water Index is a modified market capitalization-weighted index comprised of stocks that derive a substantial portion of their revenues from the potable and wastewater industry.
- » The Index begins by ranking all of the publicly-traded companies in the potable and wastewater industry by their unadjusted market capitalization and eliminates stocks which do not meet the Index's baseline eligibility requirements.
- » To meet Index eligibility, a stock must satisfy market capitalization, liquidity and weighting concentration requirements.
- » The Index selects the top 36 stocks remaining by market capitalization and assigns weightings based on ranking.
- » The Index is rebalanced on the application of the above model on a semi-annual basis.

ETF Characteristics

The fund lists and principally trades its shares on the NYSE Arca, Inc.

The fund's return may not match the return of the ISE Clean Edge Water Index. Securities held by the fund will generally not be bought or sold in response to market fluctuations.

Investors buying or selling fund shares on the secondary market may incur customary brokerage commissions. Market prices may differ to some degree from the net asset value of the shares. Investors who sell fund shares may receive less than the share's net asset value. Shares may be sold throughout the day on the exchange through any brokerage account.

However, unlike mutual funds, shares may only be redeemed directly from the fund by authorized participants, in very large creation/redemption units.
